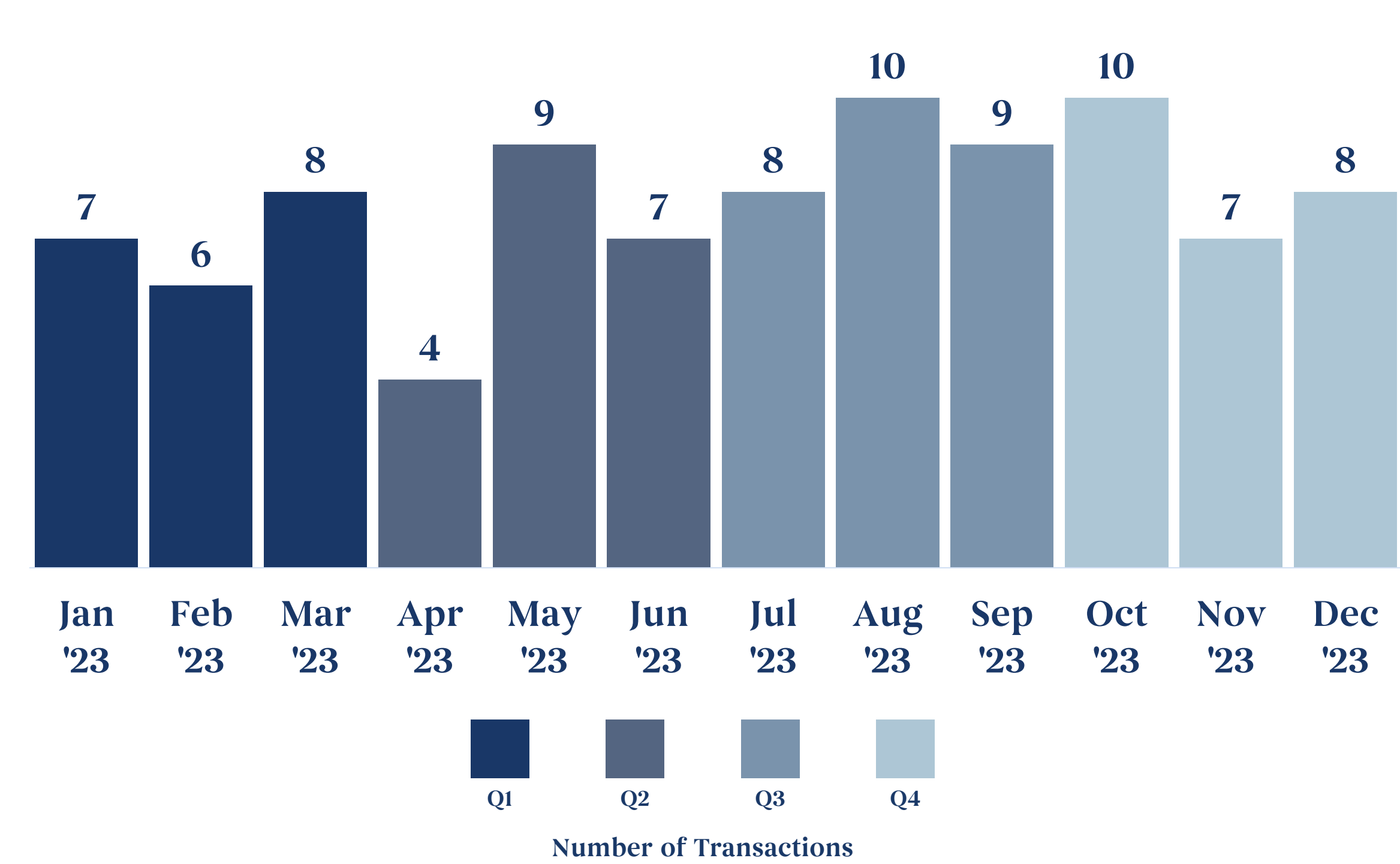

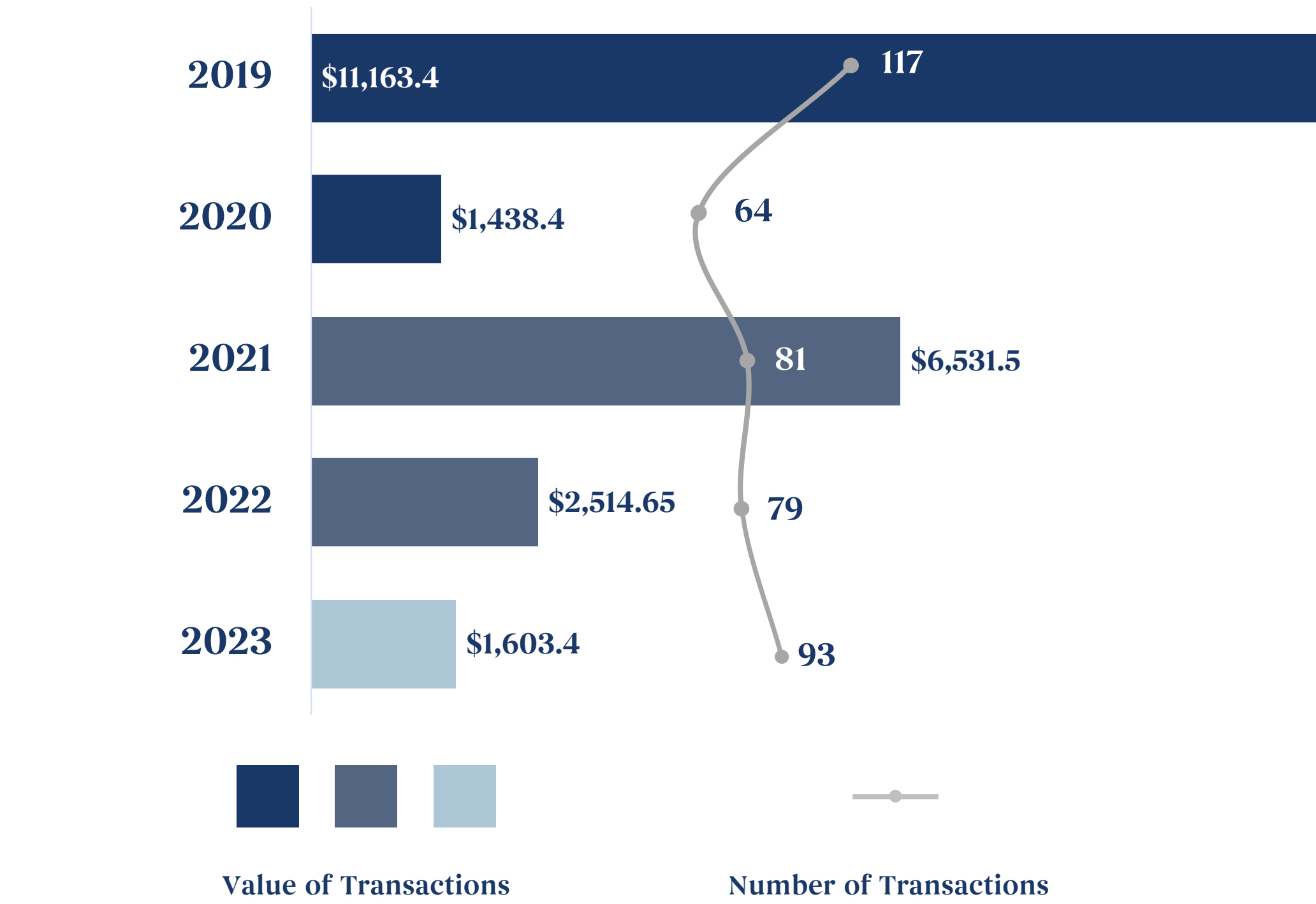
Summary of Mergers & Acquisitions in Colombia

Annual Transactions (US\$ Million)



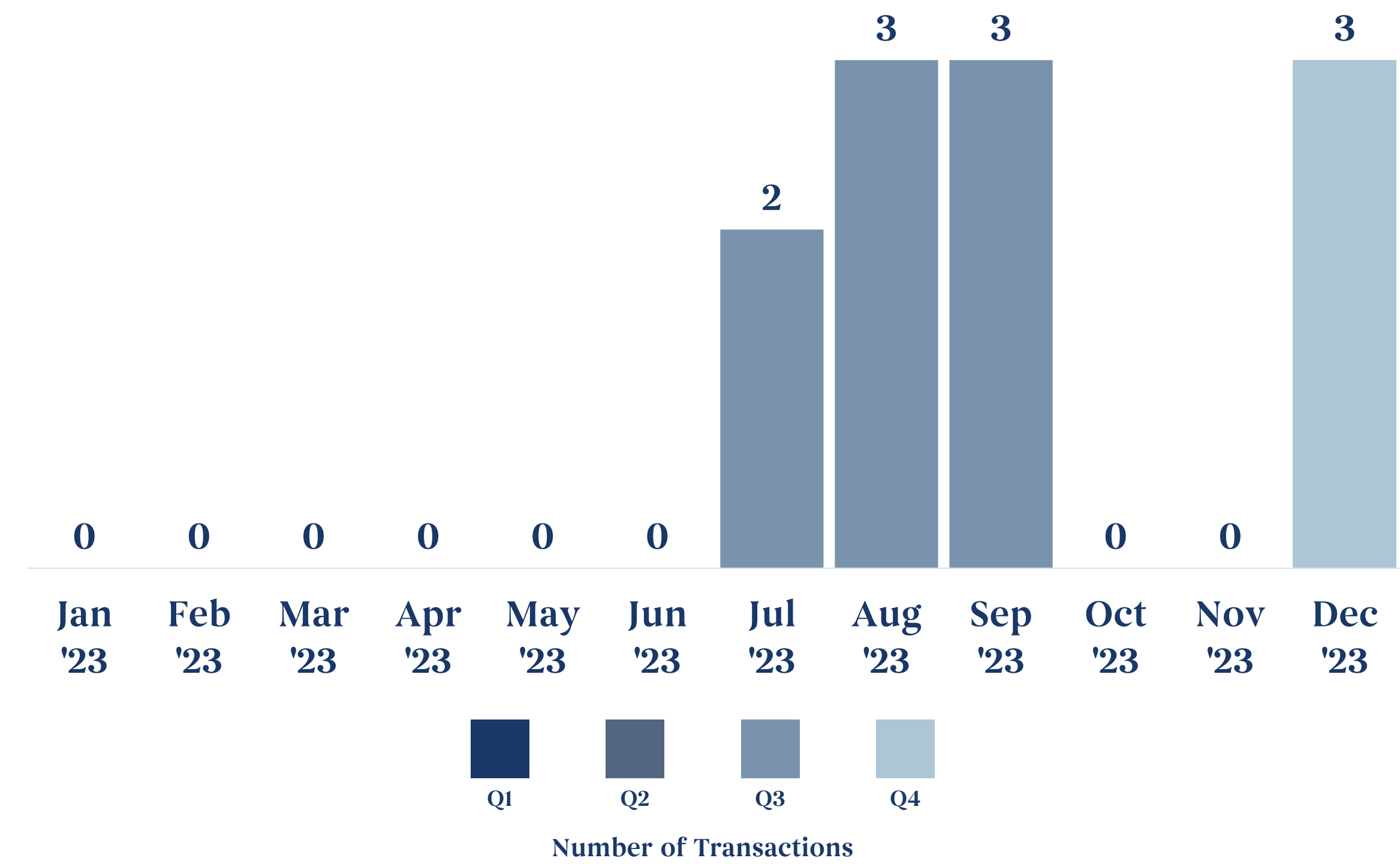

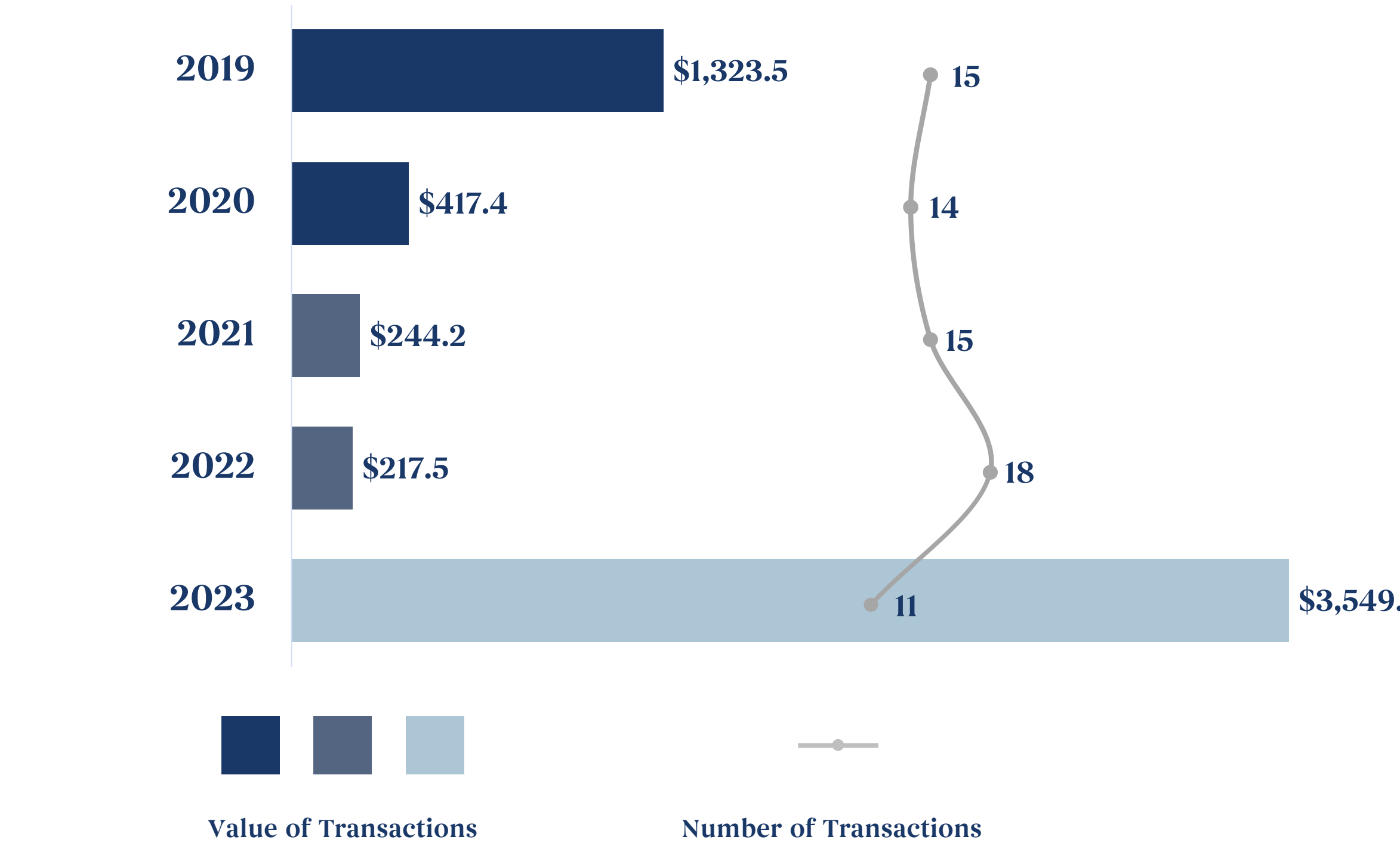
Summary of Transactions by Colombian Companies Abroad

Annual Transactions (US\$ Million)



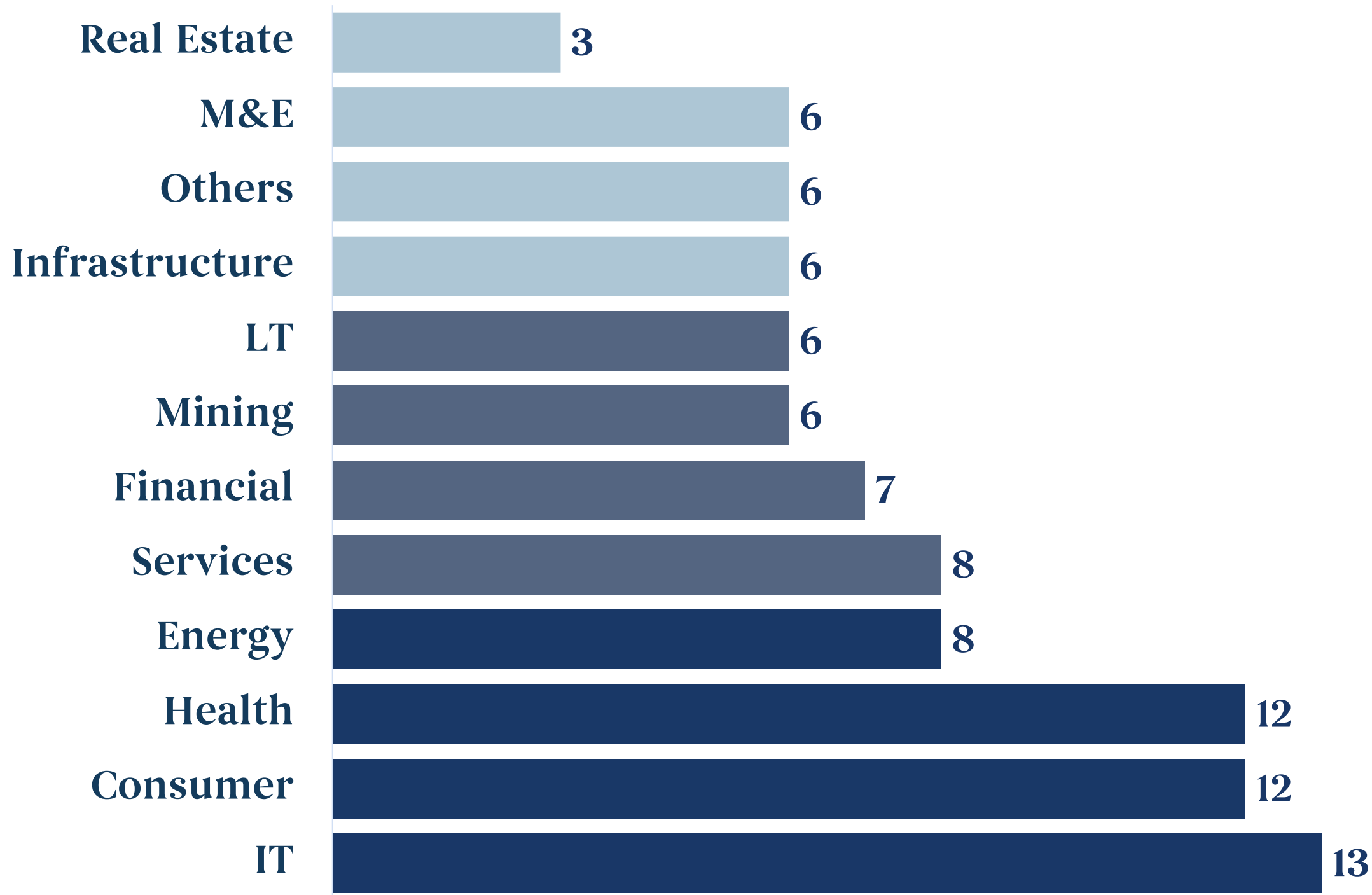

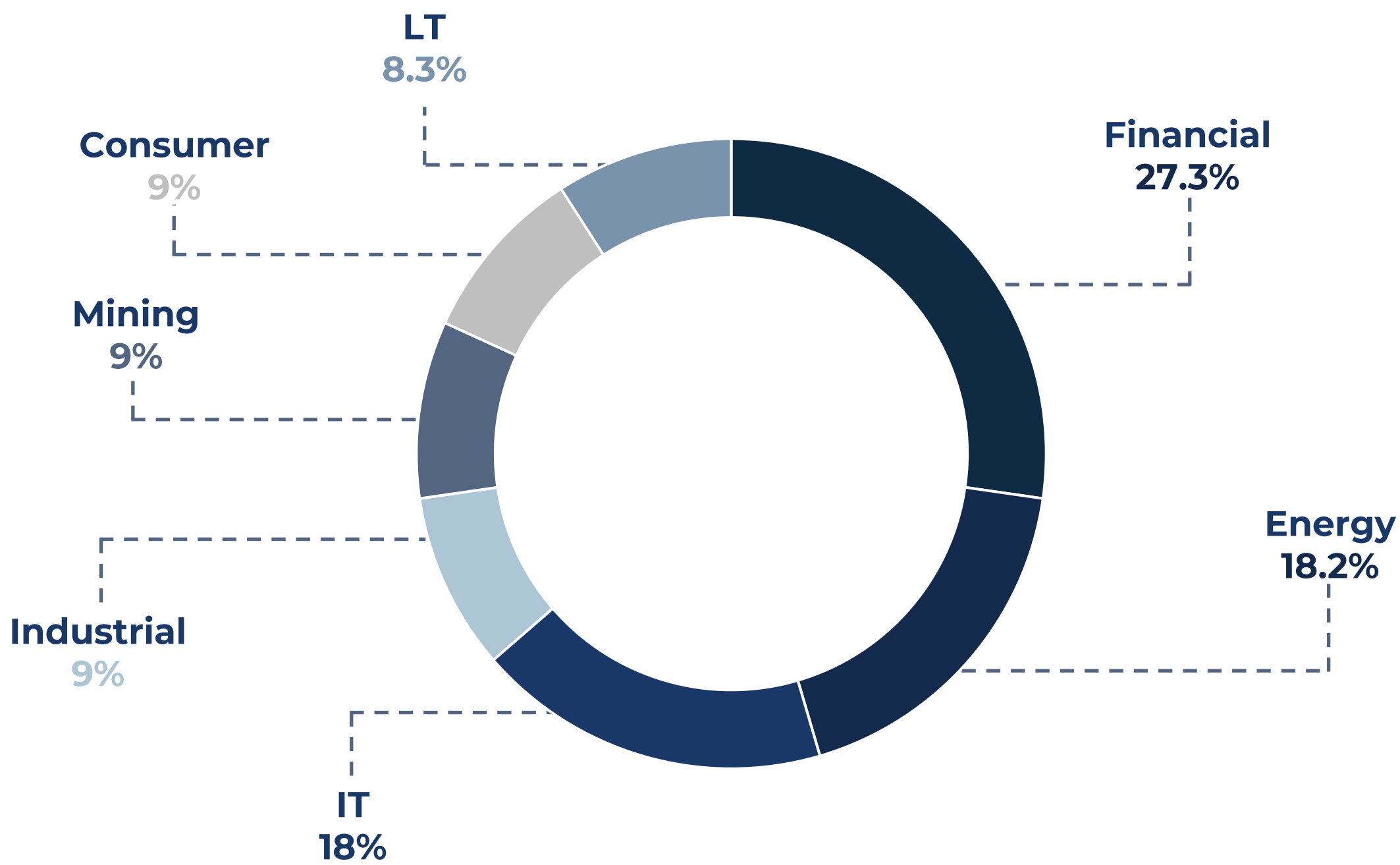
The **IT** sector led the domestic M&A activity in Colombia, with **13** announced transactions in 2023, which represents **14%** of the total announced transactions.
